# Postsecondary Student Loans:

**Cov no yog cov lus tseem ceeb uas yuav tsum paub  
thaum koj tab tom mus dhau ntawm kev thov nyiaj qiv!**

**Co-Signer:** Ib tug neeg uas tsim nyog tau txais credit, feem ntau yog niam txiv lossis tus txij nkawm, uas tau pom zoo los qhia lub luag haujlwm rau kev them rov qab rau tus menuam kawm ntawv.

**Default:** Ua tsis tau zoo hauv kev them rov qab cov tub ntxhais kawm qiv nyiaj ntau dua li cov hnub tau teem tseg lossis tsis ua raws li lwm cov nqej lus ntawm daim ntawv cog lus.

**Kev ncua sijhawm:** Kev ncua sij hawm ntawm cov nyiaj qiv rov qab.  
Cov xwm txheej rau ncua sij hawm sib txawv raws li kev qiv nyiaj.

**Delinquency:** Tsis tau them nyiaj rau cov tub ntxhais kawm qiv.  
Yog hais tias delinquency buas ntxiv, default yuav tshwm sim.

**Kev them nyiaj:** Muab nyiaj qiv rau tus menuam kawm ntawv lossis rau lub tsev kawm ntawv rau tus menuam kawm ntawv. Cov tub ntxhais kawm qiv tuaj yeem muab faib ua ntau yam kev them nyiaj.  
Kev them nyiaj yuav raug xa mus rau hauv hluav taws xob rau tus menuam kawm ntawv lub tsev kawm ntawv kom credit nws lub tsev kawm ntawv tus account.

**Forbearance:** Kev npaj ncua lossis txo tus qiv nyiaj txhua hli rau lub sijhawm txwv thiab teev tseg, lossis ncua sijhawm them rov qab. Tus neeg qiv nyiaj tau them paj paj thaum lub sijhawm ua siab ntev.

**Txaus siab:** Tus nqi them rau qiv nyiaj. Cov nqi paj yog ntxiv rau tus thawj tswj hwm ntawm cov nyiaj qiv.

**Cov paj laum:** Kev them nyiaj paj rau cov nyiaj qiv los ntawm US Department of Education rau cov tub ntxhais kawm qiv thaum lawv nyob hauv tsev kawm ntawv.

**Thawj Tswj Hwm:** Cov nyiaj qiv los ntawm tus tub kawm ntawv ua ntej them nyiaj paj.

**Daim Ntawv Cog Lus:** Cov ntaub ntawv raug cai kos npe los ntawm tus neeg qiv nyiaj ua ntej tau txais ib tus menuam kawm ntawv qiv. Dhau li muaj cov lus cog tseg kom them rov qab cov nyiaj qiv, nws teev cov xwm txheej ntawm cov nyiaj qiv thiab cov nqe lus them rov qab.

**Kev Pabcuam:** Tus neeg txais nyiaj qiv xa cov nqi qiv nyiaj rau kev them nyiaj, sau cov nyiaj them rau tus qiv nyiaj thiab tswj tus qiv nyiaj qiv nyiaj. Cov qiv nyiaj, zoo li US Department of Education, them cov neeg pabcuam los muab txoj haujlwm no.

## **Federal Subsidized and Unsubsidized Direct Loans**

Tsoom fwv teb chaws ua rau Direct thiab PLUS qiv ncaj qha rau cov tub ntvhais kawm los ntawm cov tsev kawm ntawv thoob plaws lub tebchaws. Tsis muaj lub tsev txhab nyiaj lossis cov koom haum lav nyiaj koom nrog. US Department of Education yog tus qiv nyiaj.

Subsidized Direct Loans raug faib tawm ntawm qhov kev ntsuas raws li qhov xav tau.

Tsoom fwv teb chaws them cov paj laum thaum tus tub kawm ntawv nyob hauv tsev kawm ntawv.  
Unsubsidized Direct Loans tsis xav tau raws li. Cov paj laum muaj txiaj ntsig thaum tus menyuan  
kawm ntawv nyob hauv tsev kawm ntawv.

Cov paj laum yog tib Yam rau tsuum fwv Direct Subsidized thiab Unsubsidized Loans. Cov paj laum rau cov nyiaj qiv tshiab los ntawm Lub Xya Hli 1, 2020 txog Lub Rau Hli 30, 2021 yog 2.75% rau cov kawm tiav. Rau cov tub ntxhais kawm tiav, qhov sib piv cov paj laum yog 4.3%. Tus nqj koj them rov qab yog nyob ntawm seb koj qiv nyiaj ntau npaum li cas.

## Kev tsim nyog yuav tsum muaj:

Koj yuav tsum mus kawm ntawv tsawg kawg yog ib nrab sijhawm, thiab koj lub tsev kawm ntawv yuav tsum txiav txim siab txog koj qhov kev xav tau nyiaj txiag.

## Federal PLUS Loans

Tsoom Fvw Teb Chaws PLUS Cov Nyiaj qiv yog qiv rau cov niام txiv ntawm cov tub ntxhais kawm ntaww qib siab thiab cov tub ntxhais kawm hauv cov kev kawm tiav thiab kev tshaj lij. Cov paj laum rau cov nyiaj qiv tshiab txij Lub Xya Hli 1, 2020 txog Lub Rau Hli 30, 2021 yog 5.3%.

## **Kev tsim nyog yuav tsum muaj:**

Tsoom Fww Teb Chaws PLUS Cov Nyiaj qiv yuav tsum tau kuaj xyuas lawv cov credit. Cov neeg qiv yuav tsum yog neeg xam xaj Asmeskas lossis cov neeq tsis yog peij xeem tsim nyog.

Cov neeg qiv nyiaj tuaj yeem qiv txog tus nqj txhua xyoo ntawm kev tuaj koom rho tawm ib qho kev pab nyiaj txiaq tau txais rau cov tub ntxhais kawm cuv npe tsawg kawg ib nrab sijhawn. Tsis muaj lub peev nyiaj qiv nyiaj txhua xyoo lossis lub neej.

Txhawm rau ua ntawv thov, cov tub ntxhais kawm kawm tiav lossis cov haujlmw tshaj lij, lossis cov niam txiv ntawm cov tub ntxhais kawm ntawv qib siab, yuav tsum ua tiav daim ntawv thov qiv nyiaj PLUS. Cov ntawv thov muaj nyob online.

## **State Loan program: SELF Loan**

SELF Loan yog Minnesota qiv nyiaj. Kwy yees li ntawn 400 lub tsev kawm ntaww hauv Minnesota thiab tawn hauv lub xeev koom nrog txoj haujlm. Yog xav paub seb lub koom haum koom nrog, mus saib hauv [www.selfloan.state.mn.us](http://www.selfloan.state.mn.us).

Cov tub ntxhais kawm muaj peev xwm xaiv tau ib qho kev ruaj khov- lossis hloov pauv-tus nqi SELF Loan. Tus nqi taag yog 4.85%, thiab tus nqi sib txawv voo 2.6% thaum Lub Xva Hli 2020. Tsis muai kev lav phib xaub lossis tus nqi piab nrog SELF Loan.

Cov nyiaj qv rau cov tub ntxhais kawm cuv npe kawm hauv bachelor's degree, post-baccalaureate lossis kawm tiav cov kev kawm hauv cov tsev kawm ntawv koom yog \$ 20,000 toj xyoo. Cov tub ntxhais kawm cuv npe hauv tag nrho lwm cov kev pab cuam tsim nyog tau txais txog \$ 10,000 toj xyoo.

## Txhawm rau thov, tus menyuan kawm

Qhov siab tshaj plaws tsis tuaj yeem tshaj tus nqi tuaj koom rho tawm tag nrho lwm yam kev pab nyiaj txiag uas koj tau txais.

## Private lossis Iwm yam qiv nyiaj

Cov qiv nyiaj ntiag tug lossis lwm yam qiv nyiaj muaj los ntawm cov qiv nyiaj ntiag tug, xws li cov tsev txhab nyiaj, cov koom haum qiv nyiaj thiab qiv nyiaj lossis cov koom haum qiv nyiaj. **Nyob ntawm qhov muaj zog ntawm cov neeg qiv nyiaj / tus neeg kos npe, cov nyiaj qiv no yuav raug nqi ntawm dua li tsoomfwv qiv, lossis SELF Loan.** Yog xav paub ntxiv thiab kev pab, hu rau cov qiv nyiaj ntiag tug ncaj qha lossis tus thawj tswj hwm nyiaj txiag ntawm lub tsev kawm ntawv uas koj tuaj koom lossis npaj yuav mus kawm.

## SELF Refi Program

SELF Refi yog Minnesota cov tub ntxhais kawm qiv nyiaj qiv nyiaj rov qab. Cov neeg nyob hauv Minnesota uas tau txais daim ntawv pov thawj thiab ua haujlwm tam sim no muaj cai tau txais nyiaj rov qab txog \$ 150,000 hauv cov tub ntxhais kawm qiv nyob ntawm seb hom ntawv pov thawj tau txais. Cov qiv nyiaj uas tsis ua haujlwm tam sim no tuaj yeem tsim nyog siv cov nyiaj tau los hauv tsev thiab cov nuj nqis nrog tus txij nkawm ua tus cosigner.

Cov kev xaiv ruaj khov thiab hloov pauv tau muaj nrog 5, 10 thiab 15 xyoo cov nqe lus them rov qab. Cov paj laum txaww ntawm 2.8% mus rau 4.15% raws li lub Xya Hli 2020. Tsis muaj kev lav phib xaub lossis tus nqi pib rau SELF Refi.

## Cov Nyiaj Tau Los Raws Li Kev Them Nyiaj Rov Qab

## Public Service Loan Forgiveness

Kev zam txim rau pej xeem qiv nyiaj yog ib qho tseem ceeb rau cov neeg ua hauj lwm hauv pej xeem thiab cov hauj lwm tsis muaj txiag ntsig, thaum lawv tau them 10 xyoo ntawm lawv cov nyiaj qiv los ntawm tsoomfwv. Cov nyiaj them ua ntej lossis tom qab lub Kaum Hlis 1, 2007 tsim nyog. Cov kws qhia ntawv hauv tsev kawm ntawv pej xeem thiab cov neeg ua haujlwm hauv xeev tsim nyog. Cov txheej txheem tsim nyog thiab cov npe ntawm cov haujlwm muaj nyob hauv US Department of Education.

## Loan Consolidation/Refinancing
